Visitor Declaration

The Fremantle Prison tunnels tour is a soft adventure experience that is not without an element of risk. The two and half-hour tour includes the negotiation of stairs, ladders, uneven surfaces, narrow passageways and paddling small watercraft. Whilst students will be provided with equipment for their safety and comfort, the experience involves physical exertion and requires a reasonable level of fitness, flexibility and coordination.

There are a number of conditions that may have an effect on a person's to participate safely in the tour such as a fear of enclosed spaces; claustrophobia; fear of heights; vertigo; angina or any other heart condition; high blood pressure; visual impairment (other than wearing glasses or contact lenses); severe or uncontrolled asthma; diabetes or epilepsy; a limb or back injury, or any other physical impairment or medical condition that affects your ability to walk, climb ladders, access confined spaces, board and control small paddle craft. ***If you are an expectant mother or are recovering from a medical procedure, you are advised not to participate on this tour.***

If the student has any of these conditions, or any other condition not listed above that you reasonably suspect may put their safety and health at risk and that of other visitors and employees of Fremantle Prison on your tour, you should consider whether or not they should participate on this tour. As items of personal property are not permitted on the tunnels tour, a teacher or responsible adult will need to make arrangements with the Tour Leader to carry any essential medication whilst on tour (for example, asthma inhalers).

A condition of entry to the underground sections of the tour is that students are able to be fitted with the safety equipment provided by Fremantle Prison.

Parent / Guardian DECLARATION

I declare that my child:

1. Is over 12 years of age.
2. Does not have a health, physical or psychological condition that will put their own safety and health at risk or that of any other participant on the tunnels tour.
3. Is not taking any form of medication that may affect their capacity to undertake the tour safely.
4. Understands they may not take any items of personal property on the tour without the express permission of my Tour Leader.
5. Understands they will not damage, deface or remove any element or part of Fremantle Prison, the tunnels or any of the equipment issued to me.
6. Understands they will obey and follow the instructions of the Tour Leader at all times and will respect and not interfere with the enjoyment of the tunnels tour by other visitors, and that they will be removed from the tour without refund if they do not comply with these or any of the above requirements.
